

TNT PARTY RENTALS

Liability Waiver, Release, and Rental Agreement

IMPORTANT NOTICE: PLEASE READ THIS DOCUMENT CAREFULLY BEFORE SIGNING. BY EXECUTING THIS AGREEMENT, YOU SURRENDER CERTAIN LEGAL RIGHTS CONCERNING PHYSICAL INJURY, PROPERTY DAMAGE, AND LIABILITY.

1. Assumption of Risk & Safety Mandates

The undersigned "Renter" (Lessee) acknowledges that operating, climbing, sliding, and utilizing inflatable amusement equipment involves inherent risks of severe physical injury. These risks include, but are not limited to, scrapes, bruises, bone fractures, concussions, or severe permanent injuries. Renter voluntarily assumes all structural, operational, and environmental risks associated with the rental and agree to strictly enforce the following safety mandates at all times:

- **Active Adult Supervision Required:** A designated, sober, and competent adult (18+) must physically monitor the inflatable at the entrance at all times. **The unit must never be left unattended while inflated.**
- **Age & Capacity Guidelines:** Participants must be grouped strictly by similar size to prevent accidental mid-air collisions. Never mix adults/teenagers and small children inside the unit simultaneously. Maximum capacities and weight limits posted on individual product descriptions must be rigorously followed.
- **Prohibited Items & Behavior:** All footwear, eyeglasses, sharp jewelry, pocket knives, or loose accessories must be removed prior to entry. No flipping, wrestling, somersaults, or body-piling. Do not allow riders to climb, sit, or hang on exterior walls, safety ramps, protective mesh netting, or structural roofs.
- **Slide Etiquette:** If the rented unit features a slide, only one rider per lane is permitted at any given time. Riders must slide **feet-first only**, with their back against the slide vinyl. The bottom exit area of the slides must be cleared immediately.
- **Health Restrictions:** Pregnant women, individuals with pre-existing back, neck, or joint injuries, or anyone susceptible to injury from physical falls or exhaustion are strictly prohibited from entering or using the equipment.

2. Site Requirements & Environmental Closures

- **Surface & Preparation:** Renter is responsible for providing a completely flat, level setup area cleared of pet waste, rocks, sticks, and sharp debris. Setup must be on grass (secured via heavy stakes) or concrete/asphalt (secured via heavy sandbags). **TNT Party Rentals will not set up on dirt, gravel, sand, rocks, or mud.**
- **Power Source:** A dedicated, functional 110V household electrical outlet must be located within 50 feet of the setup area.
- **Severe Weather Policy:** For the safety of all participants, the Renter must immediately evacuate the unit and turn off the blower motor if local winds exceed **15 mph**, or in the event of lightning, heavy torrential downpours, or if ambient temperatures drop below **40°F**.

3. Booking, Cancellations & Financial Terms

- **Deposit Policy:** A **25% deposit** of the total rental invoice is required to secure your reservation date. This deposit is fully refundable if and only if cancellation is executed within **48 hours** of the initial booking timestamp. After 48 hours, the deposit is strictly non-refundable.
- **Standard Cancellations & Rainchecks:** Cancellations made after the initial 48-hour window but by **9:00 PM the day before the event** will receive a digital raincheck credit valid for any rental within 12 months. Cancellations made on the day of the event forfeit the deposit entirely with no exception.

4. Post-Rental Inspection & Damage Liabilities

Upon pickup, all equipment will be fully inflated and inspected by a representative. Renter agrees to accept direct financial liability for the following policy violations:

Zero Tolerance Silly String Policy: Silly string contains corrosive chemicals that permanently burn, stain, and melt commercial vinyl. **A minimum \$300 specialized cleaning fee will be assessed for any trace of silly string.** If the structural integrity of the vinyl is compromised requiring total unit replacement, fees can reach up to **\$5,000**. We strongly advise completely banning silly string on your property during the event.

- **Unauthorized Water Use:** Units rented dry must remain dry. Introducing water hoses, pools, or water balloons to a dry item will result in an immediate **\$100 wet-unit drying and sanitation fee**.
- **General Contamination:** Food, drinks, gum, candy, slime, glitter, and face paint are strictly banned inside the unit. Excessive dirt, mud, or staining will result in a **\$100 detailing fee**.
- **Emergency Deflation Protocol:** If a unit begins losing air pressure during your event, safely evacuate all riders immediately. Verify power source connections, ensure the blower motor air intake is clear of debris, and confirm all rear fabric blower tubes are tied tightly shut.

5. Release of Liability and Indemnification

By signing below, the Renter agrees to defend, indemnify, and hold harmless **TNT Party Rentals**, its owners, operators, and employees, from and against any and all claims, lawsuits, damages, losses, liabilities, or expenses (including legal and attorney's fees) arising out of or resulting from the use, operation, or possession of the rented equipment. This includes, without limitation, any injury to persons or damage to property, even if caused by the alleged or active negligence of TNT Party Rentals.
